
- Section of dactyloscopic identification of persons

Tenprint card processed


National database as at 9/2018

- Criminal **584 902** (palm 522 507)
- No criminal **121 594**
- Latent **60 392**
- Each year on average **18,000** criminal tenprint cards
- Each year on average **7,500** non-criminal tenprint cards
- Non-criminal
- Highest growth before entering of the EU on 1 May 2004
- 2000 – 2003 **80,515**
- 2004 – 9/2018 **101,125**
- Tenprint cards of foreigners are continuously discarded



CZ TRANSACTIONS SENT TO EURODAC CS 2004-2017





Figure 3: Proportion of processed transaction per user

a new legal proposal for Eurodac is being negotiated. A major functional Eurodac evolution of Eurodac will be implemented upon approval of this proposal.

CAT1 - applicant for international protection

CAT2 - irregular crossing of external border

CAT3 - illegally staying in MS

CAT4 - request of LEA


CAT5 - request of Europol

CAT9 - special search

Eurodac Reform 2/2



- **FP - taken from 6 years of age**
- **Take a photo of a person**
- **Implementation of face application**
- **More descriptors**
- **Access for LEA to make search of descriptors**
- **FP search - all categories x all categories**
- **Person relocation**

➤ **Storage length:**

K1 – 10 years

K2, K3 – 5 years

Next Generation Prüm

- 2018/2019 - all MS operational
- Revising Decision 2008/615/JHA and Decision 2008/615/JHA after 10 years
- Austria “Prüm like contract”
Fully automated/semi automated personal data exchange
- Face application
- Europol search AFIS MS



What could help?

- Implementation of next type of biometric identification
- Systematic biometric cross checks against all national recorded data types (asylum, illegal migration, illegal border crossing, criminals, crime scene latents)



- Change of legislation, technical connectivity between national and international databases.
- Each authority (NON LEA as well LEA) has to attempt a correct identification and further make a correct decision. This helps to protect the Schengen area
