# **COUNCIL CONCLUSIONS - 1 DECEMBER 2011**

In order to foster cooperation between police and judicial authorities across the European Union with a view to creating a European Forensic Science Area by 2020, Member States and the Commission will work together to make progress in the following areas, aiming to ensure the even-handed, consistent and efficient administration of justice and the security of citizens:

- 1. accreditation of forensic science institutes and laboratories;
- 2. respect for minimum competence criteria for forensic science personnel;
- 3. establishment of common best practice manuals and their application in daily work of forensic laboratories and institutes;
- 4. conduct of proficiency tests/collaborative exercises in forensic science activities at international level;
- 5. application of minimum quality standards for scene-of-crime investigations and evidence management from crime scene to court room;
- 6. recognition of equivalence of law enforcement forensic activities with a view to avoiding duplication of effort through cancellation of evidence owing to technical and qualitative differences, and achieving significant reductions in the time taken to process crimes with a cross-border component;
- 7. identification of optimal and shared ways to create, update and use forensic databases;
- 8. use of advances in forensic science in the fight against terrorism, organised crime and other criminal activities;
- 9. forensic awareness, in particular through appropriate education and training of the law enforcement and justice community;
- 10. research and development projects to promote further development of the forensic science infrastructure.

# **COUNCIL CONCLUSIONS - 1 DECEMBER 2011**

- The European Network of Forensic Science Institutes (ENFSI) worked on most of the aforementioned actions, but as a mere network of differently organized institutes official authorities connected with Police or Justice as well as commercial and university organizations, the network lacked of financial and political support for dealing with all 10 actions properly.
- ENFSI requires from and assists its members accreditation according to ISO 17025
- ENFSI's Standing Committees and Expert Working Groups provide
  - Best Practice Manuals
  - Proficiency Tests and / or Collaborative Excercises
  - Forensic Databases
  - Research & Development

#### 1. BEST PRACTICE MANUALS

Stock taking exercise on the available BPMs in different forensic science areas, the updates needed and the gaps that still exist (COM, ENFSI)

#### Implement the Council Conclusions by:

- Sharing of existing BPMs for different forensic science areas with non-ENFSI members
- Developing new BPMs and updating existing BPMs
- Stimulating the use of BPMs by forensic service providers (MS and ENFSI)
- Translating BPMs in all EU languages (MS assisted by ENFSI)



#### MEASURES REGARDING ACTION 1 OF THE ACTION PLAN

- I. Raising awareness and application of BPMs:
  - Additionally to BPMs already published on enfsi.eu, all existing ENFSI BPMs should be published here (activity 3a).
  - Ask the ENFSI members to take into account ENFSI BPMs by setting up their own quality management systems (activity 3c).
  - 3. Inform EA continuously about the existence of BPMs (activity 4).
  - 4. Ask the ENFSI members to inform their national accreditation bodies about the existence of BPMs (activity 4).

#### MEASURES REGARDING ACTION 1 OF THE ACTION PLAN

# II. Development of BPMs (activity 3b)

- 1. Ask the ENFSI EWGs to develop BPMs in particular in areas with an identified lack of BPMs, but also to revise existing BPMs at regular intervals.
- 2. Ask the ENFSI EWGs to take actively part in standardization activities worldwide, e.g. in ISO, OSAC etc.

# III. Subsidization (activity 2)

- 1. Seek for additional funding from national and European funding programs for the development of BPMs.
- 2. Invite the ENFSI members in need of BPMs in their native language to ask for funding from national or EU programs (activity 3d).

#### 2. DATABASES

- Evaluate outcomes of projects such as 'Towards the Development of Pan-European Databases in Forensic Science', EFFECT, ODYSSEY and RESPONSE and use as input to develop appropriate strategy to enhance exchange of forensic evidence (ENFSI, MS, Europol, COM)
- Develop new research projects using H2020 funding instruments to prepare the future in this area
- Are there similar national databases for forensic exchanges and which kind of forensic data is suitable for such online exchange (ENFSI in cooperation with the Member States)
- Discuss forensic facial databases as a complementary biometrical identification parameter (Member States, in coordination with ENFSI)

### MEASURES REGARDING ACTION 2 OF THE ACTION PLAN

- IV. Support the increased exchange of forensic data between Member States
  - 1. Execute the project "Towards the Development of Pan-European Databases in Forensic Science" in time and evaluate the outcomes.
  - 2. The ENFSI Board together with the General Secretariat of the Council of the European Union and the European Commission will continually ask Europol to provide a suitable platform and technical support for the exchange of forensic data.
  - 3. The ENFSI members will use all available measures to bring forward the demand for administrational and technical support by Europol through their national representatives in the relevant panels and committees.

#### **ACTION – 1.2**

#### Facilitate the establishment and sharing of Forensic Databases.

#### **Description:**

Map out the most relevant areas where common European databases would be beneficial to be applied. Ensure the data collected are harmonized and thus comparable. Make a clear separation between knowledge databases and case related databases.

Work with Europol to achieve a solid platform and maintenance system for forensic databases.

Work with the EC to provide funding for the development of new databases and their implementation into a common network.

- Ask the ENFSI EWGs to design PTs and to co-operate with professional PT providers in order to raise quality and quantity of available PTs (activity 5).

#### VII. Subsidization

- 1. Ask COM for special funding regarding the development of PTs and ask the ENFSI EWGs to come up with respective proposals.
- 2. Ask the ENFSI members in need of PTs to ask for funding from national or EU programs.

#### LESSONS LEARNED - FURTHER CONCLUSIONS

#### 1. Task Force versus Advisory Board

- The Task Force acted more like an advisory board
- It is difficult enough to co-ordinate 7 to 8 people and come to mutual conclusions, more over to discuss suitable measures with approx. 20 stakeholders
- Permanent communication is essential

#### 2. State of play

- Will we ever achieve a European Forensic Science Area?
- Do we really have problems with mutual recognition of forensic evidence in Europe?
- Accreditation shall give us consumer confidence in forensic science!
- ENFSI provides a platform for professional information exchange between forensic scientist → Best practices, Research & Development, crucial (background) data

#### 3. The Commission and Europol

- Despite the strong international co-operation in forensic science, standards set by law or governmental regulation may help improving consumer confidence in forensic science!
- Europol as a European Agency may provide more sustainable solutions for secure forensic databases than a variety of national solutions, depending on the resources of smaller organizations and their management decisions!
